Public Portion Carl Yaccobacci of 10 Lombardi Drive addressed the Board and Agency. Mr. Yaccobacci stated at the inauguration the Mayor made a speech of how the Preferred Developer Agreement does not offer the City the flexibility necessary to move the project along at the speed best for the City. Also the Mayor said it was his desire to do whatever is necessary within the law to keep the project moving. Also promised was there would be no money leaving the pockets of hard working Derby citizens to fund any gap. Mr. Yaccobacci said that he hopes that goes through. With the special taxing district, up to 45 million dollars whichever developer can get for infrastructure should be more than enough. Because, that is 45 million dollars over the course of 20 years the taxpayers of Derby will not see. Although there is not money going out, the Town of Derby will not see that 45 million. Also, Mr. Yaccobacci stated he feels there are two different types of developers; one that comes to the City and says what can you do for me?, and another kind of developer that comes to the City and says what can we do for you? Mr. Yaccobacci said he hopes whether it is this developer or another one, it is the one who says what can we do for you?
