### Additions, Deletions, Corrections and Adoption of Agenda:

**Public Portion:** Carl Yaccobacci – 10 Lombardi Drive. Mr. Yaccobacci read in the

paper about the litigation between the City and the developer. He wanted to know if there is a loss and the developer wins its case do the tax payers have to pay or does the City have insurance that would cover taxpayers, so it wouldn't come out of taxpayer dollars. Mr. Bomba will get information to him on that.

**Sheila O'Malley** City of Derby Blight Grant Money Ms. O'Malley said the City is

entering into contract negotiations with an environmental company (Enviro Med) who is going to prepare an abatement package. That will be combined with demo specs to go out to bid for demolition for the four blighted structures. Corporation Counsel is reviewing the contract. Mr. Bomba asked if there is a tentative date for the

demolition. Sheila and the Mayor met with the State who said they were comfortable with the City proceeding with the bid process as long as the successful bidder knows the City has to wait for the State funds. The properties are two on Olivia and two on Lafayette which are owned by the City.

<u>DOT Parcel</u> The City received approval for funds for final design and permitting from the federal government. The City is working on matching a federal grant which the Mayor received a verbal commitment for 50% of construction dollars for the road. She is working on state funding for the remainder of that. Once the permitting and final design phase is complete the City can then act on the construction.
