The regular meeting of the Derby Board of Police Commissioners was held on Monday, February 12, 2007 at the Derby Police Department, 125 Water Street, Derby.

The meeting to order at 6:25 p.m. By Comm. Estwan. Present were Commissioners Estwan and DiSorbo. Also present was Chief Mascolo.

Additions, Deletions, Corrections to Agenda

There were no additions, deletions or corrections to the agenda.

Public Portion:

Kathy Norwood, 4 Lanzieri Court representing Detention Basin LLC stated that she is looking for a curb cut at the end of Lanzieri Court so that she may have access to the property that she owns. The detention basin is located on this property and she needs access to it so that she may do the work necessary to clean the basin. She stated that the City of Derby has an easement which goes through her next door neighbor's property to get to the property in question. The neighbor parks vehicles in that location so that she has no access. The clean up work was ordered by the Inland Wetlands Agency and DEP and she needs to get equipment in there. Mr. Estwan stated that the Public Works Department send requests to the Traffic Authority to make the curb cut. He stated that he would like to have the City Engineer look at this and then put this item on the agenda for resolution. He felt that it needed to be researched before it can be granted.

John Norwood, 4 Lanzieri Court stated that his neighbor parks a commercial vehicle in front of the house and would like to not have that happen. He stated that he has contacted the Police Department about this a number of times. Chief Mascolo stated that officers have responded many times and there is not much that can be done but he will look into the matter.

Department Reports

The Commissioners reviewed the Department reports. Chief Mascolo stated that the report that is submitted to the Board of Aldermen has been amended. He also stated that a Capital Planning meeting will be coming up and the handgun purchase will be discussed.

Communications

Chf. Mascolo stated that several thank you letters have been received from citizens and these will be put in the appropriate officers' files.

He also stated that official notice of retirement has been received from Donald Margiano.

Chief Mascolo stated that a FOI request was received from the CT Post asking for all names of citizens who have asked for gun permits. He referred it to the Corporation Counsel and is reluctant to do this but has been advised that after 2001 the name have to be released. He is going to look further into this before releasing any information.

Old Business:

There was no old business to discuss.

New Business:

There was no new business to discuss.

A motion to go into Executive Session to discuss personnel/disciplinary issues and contract issues and to have Chief Mascolo attend was made by Comm. DiSorbo, seconded by Comm. Estwan and carried unanimously. The Board went into Executive Session at 6:45 p.m.

A motion to have a disciplinary hearing for IA Case No. 06-10084 on March 5, 2007 at 7:00 p.m. was made by Comm. DiSorbo, seconded by Comm. Estwan and carried unanimously.

A motion to adjourn was made by Comm. DiSorbo, seconded by Comm. Estwan and carried unanimously. The meeting was adjourned at 7:00 p.m.
