- In Custody Death Investigation

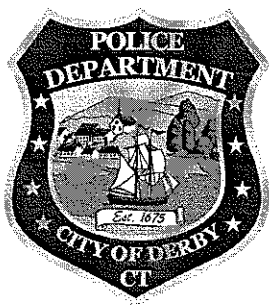
Commissioner Estwan motioned to accept the changes, Commissioner DiSorbo seconded. All were in favor and the motion passed.

There has not been a quorum at the last few Tax Board meetings for the Police Department to conduct business.
