### 6. Department Reports

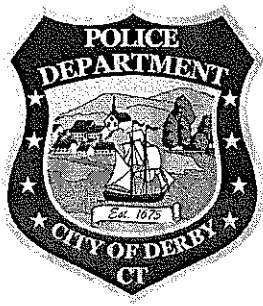
